Did you know that Kids Club of Jefferson County serves 550 kids a year, 215 kids daily?

When those kids arrive at Kids Club they are greeted into a welcoming place where they feel safe and are excited to play and learn new things.

The cost for an Annual Membership is **\$150 for an entire year** with a \$300 Family Cap. This is a great price for such a great service for so many families in Jefferson County.

Something new this year - Kids Club will be open *BEFORE* school for kids. When they are there in the morning they will then be bussed to either Buff Elementary, Madras Primary, or Metolius Elementary. For working parents, this is so helpful.

Some of you may know the 509-J school district is releasing kids an hour earlier from school this year. This means that Kids Club will be open starting at 2:30 on Monday-Friday, all school year long. Even with this earlier release time, Kids Club is not increasing Membership prices. **This increased time and personnel costs will give us a shortfall of \$80,000 in operating costs.**
